Description:

Metacaulk SAS 90 Smoke & Acoustic is a high-quality, latex-based sealant formulated to reduce sound transmission and to maintain the specified STC (Sound Transmission Class) of sound-rated assemblies per International Building Code (IBC) requirements for airborne sound. Metacaulk SAS 90 adheres to most building materials and cures to form a paintable, permanently flexible barrier that prevents the passage of smoke and gasses through **non-fire-rated** penetrations and joints in smoke barrier partitions as required by the IBC.

Applications:

- One and two-sided applications
- Top and bottom runners prior to application of drywall
- Outer edge perimeter joints of drywall
- Cut-outs and utility penetrations
- Bottom of wall, wall to wall, and head of wall joints in smoke partitions
- Suitable for use in minimally dynamic joints
- Penetrations for metallic, insulated metallic, ducts, conduit, cables and wires in non-fire rated smoke partitions and acoustical assemblies (check with manufacturer for non-metallic approvals)

Limitations:

- Not for use in fire-rated floor or wall assemblies

Maintenance:

Inspect sealant at a minimum of every five years. If sealant or bond of sealant is damaged, completely remove or cut away sealant in the damaged area, clean surface, and reapply sealant.

Caulk Installation:

Surface Preparation

Surfaces should be clean of any debris or material that may prevent or deter adhesion. Such debris include, but not limited to: dirt, frost, loose particles, existing sealants, grease, oils, rust, etc.

Application

1. Cut nozzle to desired bead size. $\frac{3}{8}$ " is recommended for most applications.
2. Apply sealant on the underside of all runners at the ceiling and floor prior to the installation of drywall, the outer edge perimeter joints, cut-outs, and utility penetrations to ensure the required STC is achieved or maintained.
3. Smooth caulk using a wet finger, putty knife, spatula, or other similar means.
4. Sealant normally "skins over" in 15 minutes, dries to touch in 2 hour, and cures in 24 to 48 hours. Allow 3 to 7 days for full cure depending on ambient conditions.

Cleanup

Excess caulk should be cleaned off tools and nonporous surfaces while it is in the uncured state using a dry cloth or paper towels (soap and water may be used). Excessive amounts may require the use of a solvent such as mineral spirits. After curing, excess sealant must be cut or scraped away.

Spray Installation:

Surface Preparation

Spray application requires airless spray equipment that meets the following:

- Working Pressure: 2500 PSI (72 Bar) minimum
- Delivery: 0.72 US gpm (2.7 l/min) minimum
- Spray Tip Opening: 0.023" - 0.026" recommended
- All seals and contact surfaces should be suitable for latex emulsion contact.

Surfaces should be clean of any debris or material that may prevent or deter adhesion. Such debris include, but not limited to: dirt, frost, loose particles, existing sealants, grease, oils, rust, etc.

Application

1. A minimum of $\frac{3}{8}$ " fluid line is required, a $\frac{1}{2}$ " line is preferred. For long hose runs or lifts to higher elevations, consult pump manufacturer. A reversible spray tip is recommended. A 6" fan pattern is recommended to reduce overspray.
2. Apply sealant on the underside of all runners at the ceiling and floor prior to the installation of drywall, the outer edge perimeter joints, cut-outs, and utility penetrations to ensure the required STC is achieved or maintained.
3. Sealant normally "skins over" in 15 minutes, dries to touch in 2 hours, and cures and in 24 to 48 hours. Allow 3 to 7 days for full cure dependent on ambient conditions.

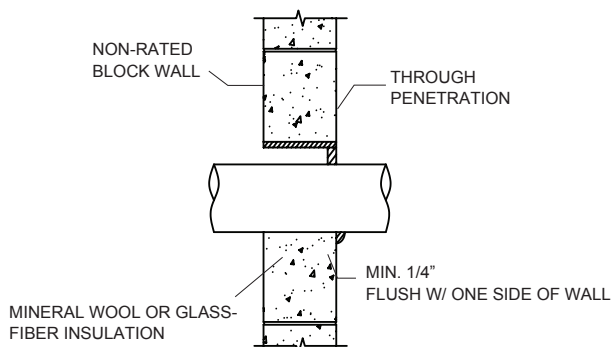

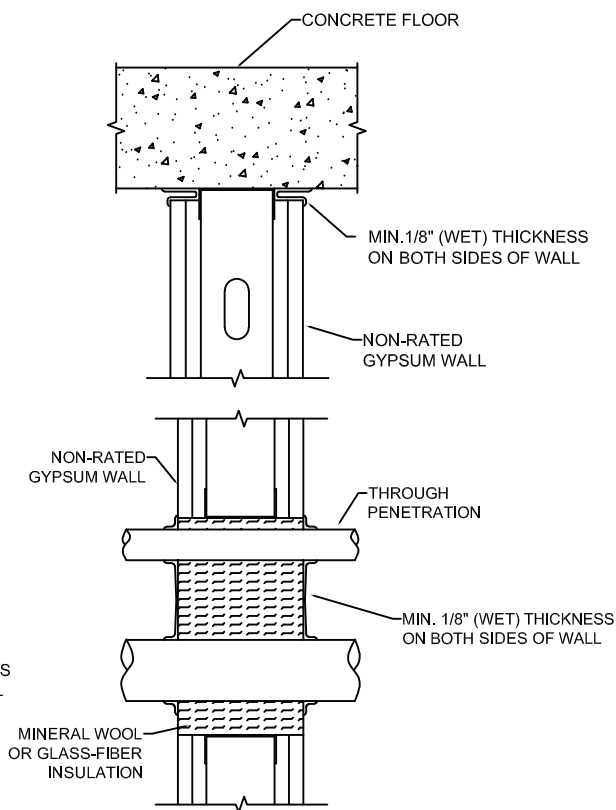
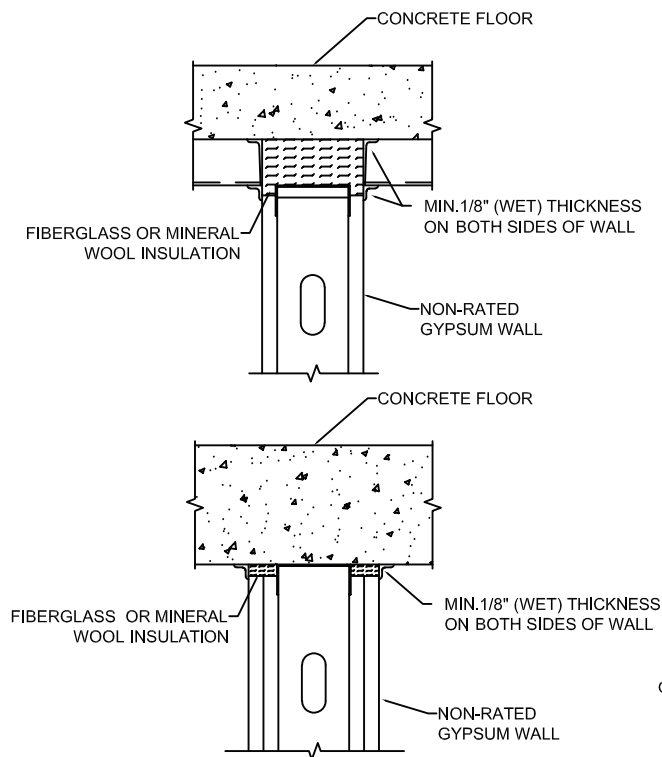

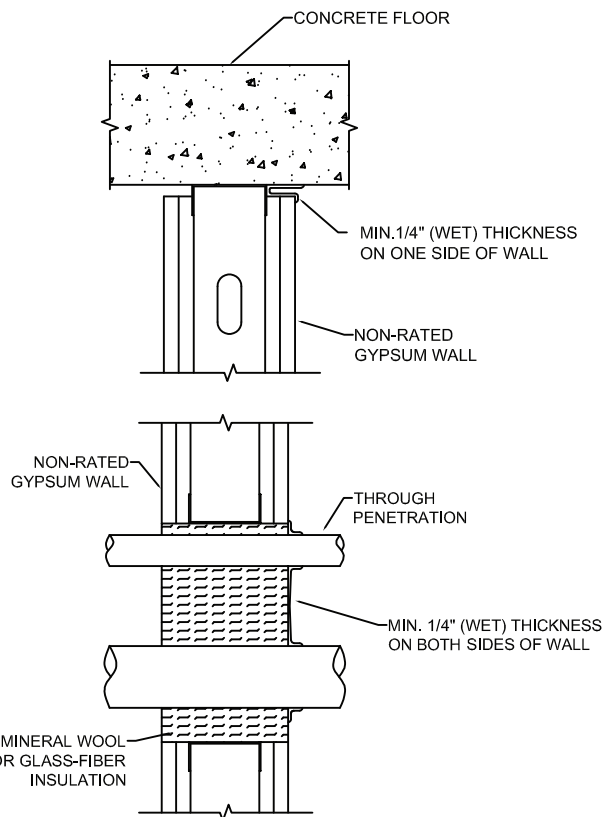
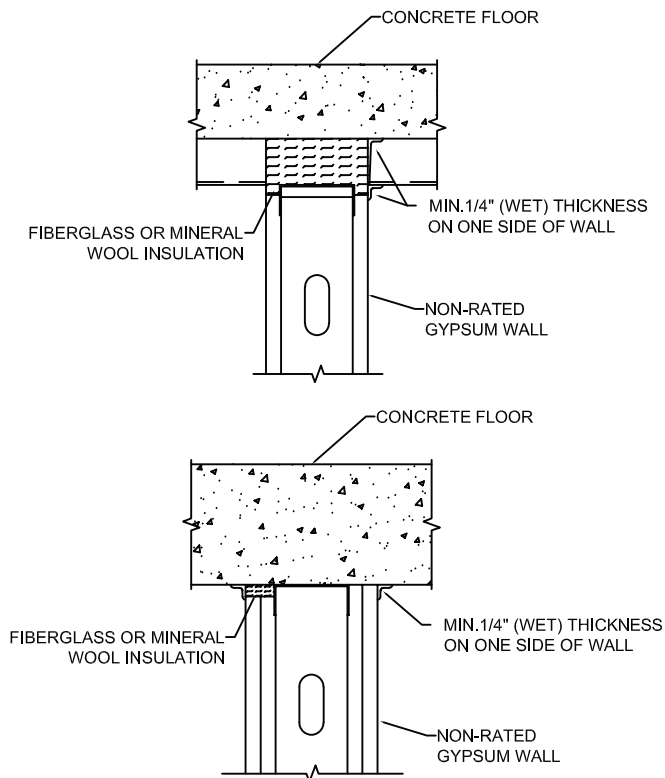
